**1. CALL TO ORDER/WELCOME VISITORS**

Mayor Belisle called the meeting to order, welcomed those present and all stood for the Pledge of Allegiance

**2. APPROVAL OF JANUARY 7, 2013 COUNCIL MINUTES**

C. Grover made motion to approve the January 7, 2013 Council minutes as presented & was 2<sup>nd</sup> by C. Graham. Motion carried unanimously.

**3. ADMINISTRATIVE/FISCAL MATTERS**

**A. Municipal Election-Set Date & Qualifying Date/Time**

Mayor Belisle made motion to set the qualifying dates for the Municipal election to be held on Tuesday, November 5, 2013 for Monday, August 26<sup>th</sup> thru Wednesday, August 28<sup>th</sup> between the hours of 8:30 & 4:30. Motion was 2<sup>nd</sup> by C. Graham and carried unanimously.

**B. Police Radio Purchase**

C. Graham made motion to approve the purchase of 2 Motorola radios at a cost of \$6,237.60 & was 2<sup>nd</sup> by C. Grover. Motion carried unanimously.

**C. Library Books Purchase**

C. Grover made motion to approve the purchase of library books as requested by the Coweta County Library System for the Senoia Library in the amount of \$22,029.38 to come from Library Impact Fees. Motion was 2<sup>nd</sup> by C. Graham and carried unanimously.

**5. NEW BUSINESS**

**A. Preliminary Plat-10 Standing Rock Road**

Grover made motion to approve the Preliminary Plat at 10 Standing Rock Road for 2 residential lots as recommended by the Planning Commission. Motion was 2<sup>nd</sup> by C. Owens and carried unanimously.

**B. Historical Society Sign Request**

Grover made motion to approve the 2x2 Senoia Historical Society directional sign that will sit at the corner of Couch & Main Street on a 4x4 post. Motion was 2<sup>nd</sup> by C. Owens and carried unanimously.

**C. Peachtree City Soccer Sign Request**

Dan Esmond of Willow Dell Subdivision asked Council to approve signage for PTC Soccer that can be placed until January 31<sup>st</sup> and again from July 1<sup>st</sup> thru July 31<sup>st</sup>. The signs will be erected in the same area as the approved signage for the Senoia Ball League. After short discussion, Mayor Belisle made motion to approve the signage for PTC Soccer for the dates specified to be placed according to the list approved for Senoia Ball League. Motion was 2<sup>nd</sup> by C. Graham and carried unanimously.

**D. Downtown Development Authority Update**

Rhonda Moyer of the DDA updated all of their recent activities to include gearing up for the upcoming Memorial Day Parade and celebration to again include fireworks and informed all that the building beside the Welcome Center has been rented to a general practice attorney. Ms. Moyer then invited all to the pre-construction meeting on the clearing project to be held Wednesday, January 30<sup>th</sup>. C. Owens then thanked the members of the DDA for all of their efforts.

**6. APPEARANCES FROM THE FLOOR**

**Ken Hazelton of 680 Willow Dell Drive** asked for an update of the early warning system and also lights at the Seavy Street & Hwy. 85 location. Mr. Ferry informed all that he believes that the County has tested the system and intends to have it installed by early spring and has no update on lights at Seavy Street & Hwy. 85. Mr. Hazelton recommended directional signage at Hwy. 85 & Hwy. 16 as he was informed by visitors to the City that while attempting to visit the City they ended up in Haralson.

**Don Rehman of 55 Paddle Boat Cove** asked that Council consider the purchase of a hard copy of Senoia Code of Ordinances for the Senoia Library. Mr. Ferry will inquire with the County to see if there is interest.
