4. ADMINISTRATIVE/FISCAL MATTERS

- a. **Ordinance No. 17-01 for the Rezoning of 48 Couch Street from R-40 to RH.**
Council discussed approval of Ordinance No. 17-01. Maurice Grover made a motion to approve. Jeff Fisher seconded the motion. Ordinance No. 17-01 was unanimously approved.
- b. **Consider quote from L.H. Fencing, LLC of \$8,700 for 6 foot Barnes Street Fence.**
Dina Rimi presented the quote from L.H. Fencing for a 6 foot wooden, shadow box fence. Residents, Jane Whitehurst, Karen Dowde and Zibe Dowde spoke before council and requested the City allow an 8 ft. fence due to lighting, trash and noise from the commercial development. Councilman Jeff Fisher made a motion to table the issue until the City could get a quote for an 8 foot fence. Chuck Eichorst seconded the motion. Motion was unanimously approved.

6. NEW BUSINESS

- a. Consider quote from Crawford Grading for three driveway aprons on Barnes Street. City Manager Harold Simmons presented a quote from Crawford Grading for three driveway aprons on Barnes Street for a total cost of \$4,290. Mayor Pro-Tem Bobby Graham made a motion to approve and Councilman Jeff Fisher seconded the motion. Motion was unanimously approved.
- b. Dustin Shaw Homes-Consider preliminary plat for Stallings North and South. Dina Rimi discussed the plat presented for annexation by Dustin Shaw Homes. Dustin Shaw Homes would like preliminary plat approval. Dustin Shaw spoke to council stating that there is adequate line of site for traffic issues. Councilman Jeff Fisher made a Motion to approve preliminary plat and Chuck Eichorst seconded the motion. Motion was unanimously approved.
- c. Parade request from Senoia Area Athletic Association scheduled for March 18, 2017. Senoia Area Athletic Association addressed council and requested a change to the parade route to encompass Main Street in parade route. Chief Jason Edens explained the exact route with no hard closures. A motion to approve was made by Councilman Maurice Grover and was seconded by Councilman Jeff Fisher. The Motion was unanimously approved.
- d. Mayor Pro-tem Bobby Graham amended the agenda by adding Mr. Phil Downey of the Optimists Club. The Optimists Club would like to host Taste of Senoia on April 23, 2017 from 1-5 p.m. The Optimist Club will collect trash, etc. just as it did in the Fall of 2016. Councilman Maurice Grover made a motion to approve and Chuck Eichorst seconded the motion. The motion was unanimously approved.


8. ANNOUNCEMENTS
